#### CHAIRMAN'S ANNUAL REPORT

I think that I can justify claiming that the last year has been a highly successful one for your Parish Council. It has seen the maturity of a number of important projects which we have strived for over a number of years.

Freda, our clerk, achieved her CILCA qualification in 2008 which involved an immense amount of hard work. It was the one missing element needed for our long held ambition to become a 'Quality Council' which we then applied for and achieved.

Last autumn saw the start of the building in Chorley of our six new affordable houses for local people. They will be ready for occupation this summer and great credit goes to Rosemary Abbiss and Madge Shineton for bringing this about through the Shropshire Rural Housing Association.

Another major project completed during the year was Glebe Drive Parking to reduce congestion and make school set down/pickup times very much safer. It became all the more urgent after the very successful Playgroup was encompassed into the school after many years meeting in Chorley Village Hall. This parking will also be an asset to the parish whenever there is a major function in the village. We are very grateful to Shropshire County Council both for their assistance in this project and for its completion with minimum disruption. They were also most helpful over the temporary construction to allow Winterburn Bridge to be reopened.

The icing on the year's cake must surely be winning of the Jan Snell Award (shield will be on display at Annual Parish meeting). To win this we had to demonstrate that we had achieved 'something special' over the year and I believe this award justifies my opening remarks.

As Chairman I am very lucky to have such an experienced and hard working Clerk as well as the wide range of experience, expertise and knowledge of your councillors. I am also fortunate that we seem to be able to conduct our business in a friendly and co-operative manner and I am extremely grateful to them.

Looking forward, Unitary is now upon us and there will be an election for the new Shropshire Council on 4th June. We will be part of a 2 councillor ward based on Cleobury Mortimer. During the deliberations of the Boundary Commission we have always supported this solution, as the benefits of being an active part of Cleobury Country have already been seen. I am afraid that you will not get a chance to vote out your Parish Council until 2013 - that is not of our choosing but at least saves on election expenses!

On the subject of expenses we have tried very hard to keep the increase in our precept down to the minimum. Unfortunately HMRC has imposed a new system of managing employees salaries which has increased our wage bill by 50%. In the January newsletter we set out a full account of how we set our budget and precept.

It is worth noting that all the projects I have mentioned arose directly from our Parish Plan completed four years ago when we asked you, our electors, what you wanted. That is now virtually 100% successfully completed. This compares rather favourably with some councils who have yet to start a Parish Plan! Once Unitary has settled down and we can see which way the financial winds (or storms!) will blow we intend to revisit the Parish Plan process to establish a new 'wish list' which we can then cost and prioritise

Finally I would to thank Freda and all members of your Parish Council for their hard work and the achievements over the past year. We are here to maintain and enhance the parish and serve you so if you have any problems or worries please contact any one of us.

# Parish Council Clerk:

The Clerk, Mrs Freda Morris, deals with all correspondence, accounts and day to day problems on behalf of the Parish Council.

When complaints are received the Clerk deals with these in several ways i.e.

- Complaints regarding roads, potholes, overhanging trees, road gritting etc these are reported immediately to the Highways Department of Shropshire County Council.
- Queries of any other nature and information requests are investigated by the Clerk and reported back to whoever raised the query as soon as possible.

All actions by the Clerk are quite often reported by email to all Councillors and then to the next Parish Council meeting. The Clerk takes instructions from the full Council, not any individual Councillor, and all correspondence the Clerk sends out, although signed by her, has been discussed and agreed by the full Council.

The Parish Council has a very good working relationship with the County Council and if you have any query regarding the roads do not hesitate to contact the Clerk - if she knows the answer she will tell you straight away if not she will find out and report back to you as soon as possible!

The Clerk and Councillors attend training sessions on a regular basis on various topics, i.e. Planning, Power of Well Being, HM Revenue and Customs, Code of Conduct, Accounts and Audit, Recruitment and Selection, Community Engagement to name but a few in order to keep up to date with any change in legislation etc.

## Grants:

Each year the Parish Council precepts an amount of money which is available for distribution to groups in the parish or to any organisation which benefits the Parish. This year we have supported Severn Hospice, Hope House Children's Hospice, Severn Centre, Samaritans and Citizens Advice Bureau. We have a criteria which has to be to satisfied and this will be published on the updated website.

# Parish Council website:

The Clerk is in the process of updating the website and once finished you will be able to view the previous 4 months minutes (once approved by full Council), newsletters, accounts etc. The Clerk is the 'Proper Officer of the Council' and holds the official signed minutes and all other documents. If you would like to see any documents not on the website please contact the Clerk who will be more than happy to make a convenient appointment.

# Nightingale Nursing Fund:

The Annual General Meeting of the Nightingale Nursing Fund is to be held on Wednesday 29th April at the Market Hall, Cleobury Mortimer, starting at 5.00 p.m.

This is an open invitation to anyone who is a patient of the Doctors practices of Ditton Priors, Cleobury Mortimer and Highley to attend.

# Overgrown trees and hedges:

Can we please ask once again for all landowners to check overgrown trees and hedges particularly on the roadside. The Parish Council are still actively trying to get Walton Bank hedge cut back and reduced in height but unfortunately we are getting no response from the landowner. This matter has once again been passed to Shropshire County Council.

# **Brooksmeeting Bridge:**

Many thanks to everyone for being patient during the repairs to the abutments of the bridge. The Parish Council were extremely grateful to Shropshire County Council for completing this week earlier than first anticipated and for taking the opportunity whilst the road was closed to repair the section of road which was subsiding very badly.

# **District Councillor Madge Shineton:**

Parish Councillors received the last report from District Cllr Madge Shineton at their parish council meeting last week and the chairman presented Madge with a plant to nurture! Madge has been our District Councillor for the last 10 years and has worked tirelessly for the Parish on numerous projects especially health, affordable housing and transport. Madge has represented the District Council at many committee meetings and seminars and has had a wealth of information and knowledge to pass onto the Parish Council. Madge has been invited by the Parish Council to give a final report to you the parishioners at the Annual Parish meeting. We are extremely lucky that we will not be losing Madge as she had a dual role with us as Parish and District Councillor.

# Road Closure

Unfortunately there is to be another road closure in Chorley. This will commence on Monday 20th April 2009 from 9.00am-3.00pm for 4 days in order for the sewerage to be laid to the 6 new houses.

Access will be restricted to pedestrians, dismounted cyclists and dismounted horseriders through the closure which is from Chorley Village Hall to The Duck Inn car park. The road will be open before and after these times. Can we please ask that everyone is patient during this temporary closure, which has been delayed due to the Brooksmeeting Bridge closure.

#### Friends of Stottesdon Primary School (FOSPS) News:

This year we are going to enter a team in this Bridgnorth Walk. Currently we have about 15 walkers willing to take up the challenge! As you may be aware, the walk takes place on Whitsun May Bank Holiday which this year is on Monday 25<sup>th</sup> May. We start in Bridgnorth High Street and then begin a gruelling 22 mile hike up and down the Brown Clee, returning to Bridgnorth. We would really appreciate your support.

Also, our fete this year is now taking place on **Friday 5<sup>th</sup> June at 6:00pm** in the grounds of Stottesdon C of E School and within our lovely school garden – weather permitting!! We can already look forward to hearing a brilliant local Brass Band from The Bell Inn, Cleobury Mortimer and seeing a riveting performance from Severn Valley Karate Club. There will be numerous stalls and games including a tasty BBQ, Cakes and refreshments, a tombola, an extensive plant stall plus many more. There will also be attractions such as a Steam engine, Pony Rides and a Vintage Tractor to look forward to.

It would be great to see you there - a lovely family event!

#### Debris in the River Rea:

The Parish Council are extremely concerned regarding the amount of debris causing beaver dams in the River Rea which during heavy rain causes flooding. We have been looking into this problem for some time and it has been confirmed that whoever owns the land on either side of the river, where the debris gathers, is responsible for the removal of this. We are told that the Local Authority has the power to enforce the removal of such debris or remove it and re-charge the landowner. PLEASE help us all by removing any debris washed down which unfortunately may settle by land owned by you.

## Speeding vehicles/Speed limit:

The Parish Council still receives regular complaints regarding vehicles speeding through our Parish. It is hoped that a 30mph speed limit will be implemented in Stottesdon very shortly, but can we please ask that you all **slow down** and consider other road users before there is a serious accident - please remember that our roads are very narrow. The Police are aware of the problems in the Parish.

The map showing the proposed speed limit area will be on display at the Annual Parish meeting for you to come along and make any comments regarding these proposals. A similar request has been made for Chorley but at present this is not included in the villages identified for speed limits - the Parish Council will continue to monitor the situation.

Can we also please ask that 'passing places' are used where possible as the road edges and verges have been severely damaged throughout the Parish.

We hold 'parishioner's time' before every meeting open when you have the opportunity to raise any concerns/problems you might have with the Council, alternatively you can contact the Clerk or a Councillor.
