0) Public participation:

Two parishioners attended to express their concern regarding the tragic loss of Annie at The Fighting Cocks and the lack of information being received regarding the re-opening of the pub, just 'hearsay' at present.

This is a big concern for the village as it is the only pub and is the' hub of the village'. It has regularly been used to host fund raising events, quizzes, wedding, christening, birthday parties and wakes. It is a restaurant and the only place in the village with a room to hire for private events.

It was wondered if this could be registered as an 'Asset of Community Value' with the Parish Council leading on this.

The process was explained by Cllr Sierakowski.

It was agreed to write to the family (if details could be passed to Clerk) to query if this would be opening again.

This will be put o the agenda for the next PC meeting.

The two parishioners thanked the Cllrs for listening and left the meeting.
