- Mental Health - Councillor Shinerton said she was concerned about Youth Mental Health. A gentleman has now been appointed on a short-term contract to look at this issue.
- New Digital System at Shirehall. If you report anything it should update you when anything has been carried out about your reported item.
- Housing needs survey - Pilot Scheme going on at the moment at Cleobury. Will link into Health and economy and give advice on any small business that wish to set up.
